Treasurer's Report: As of February 21, 2024, we have \$13,456.35 in checking and \$8,536.90 in savings. Currently there are 4 four outstanding items: Banquet dinner, marking chalk, timing lights, and chalk sticks, totalling \$2,196.42, chalk sticks notwithstanding. Pam motioned to approve the treasurer's report as presented, seconded by Becki and approved.

Post Event Discussion

Driving School: The event ran very well overall. One criticism for the driving school was in regard to the skid pad having a large amount of downtime due to some students sitting out due to excessive tire wear and/or dizziness. It was suggested to have instructors change up the skid pad throughout the session to make the station less monotonous. Another suggestion brought up was to have a "wet" skid pad to preserve students' tires as well as making the station more interesting. We would also like to thank all instructors; the driving school could not happen without the time and knowledge they invested into the school.

Old Business

Timing Update: The timing lights have been received and will be ready.

Trailer Update: The driving school was used as a trial for making sure the trailer will not run out of power. Everything is working properly with the trailer. Gasoline will no longer be stored in the trailer. If the generator is needed in an emergency situation, someone will need to pick up gasoline.

Radio Replacement: Brandon suggested instead of replacing our entire radio set up, to instead replace batteries that will not last at minimum one full event day as well as purchasing 4 more radios to allow more people that need radios to have them.

Live Timing: AXtime has not been supported since 2015 and we should investigate possibly getting into a new system. We can run the new timing system simultaneously as a trial. To allow for live timing, we will need internet access for the trailer. The rough estimate for internet comes out to about \$65 per month. Rob motioned to approve up to \$1000 per year to allow for set up and continuation of live timing. Brandon motioned to amend to use the pre-authorized amount from the timing trailer purchases, recurring up \$1000 per year and seconded by Audrey. The motion was called to a vote to which was unanimous. The motion was carried and passed with no opposition.
